### Stella Maris in Las Palmas (by Mr. Antonio Rodríguez)

The activity of Stella Maris Las Palmas, on sailors who have been abandoned by their owners,

Stella Maris was established in Las Palmas in 1997 from the Chaplain appointed by the bishop.

It began at a time when the number of abandoned ships were 60, 12 of them with crew.

We helped with food and clothes, took them to the doctor or dentist when they needed it, and bought medicines, provided a generator for the electric motors, etc.

But one of the most important actions was the repatriation of seafarers. We achieved it thanks collections made in parishes and the port community.

Since 1997 and until today, we have repatriated 64 foreign sailors.

In most cases, the crews after spending more than four years lost any chance of recover their wages, when the ship was sold in auction to a ridiculous price.

We have also paid legal fees to arrest a ship on behalf of the crew.

pastoral work was as a vice parish priest at St Sebastian Parish, at the Curia office and as a teacher in the senior section at the collage of the De La Salle Brothers in Cottonera. The Archbishop told me that he was going to appoint me Port Chaplain and Rector of Our Lady of Liesse church in Valletta, the capital city. This church is situated exactly at the entrance of the Grand



Harbour and serves us the home for the Apostleship of the Sea. The Archbishop wanted to appoint me as Port Chaplain because the Franciscan Friars could no longer continue with this Apostolate mission.

Here I would like to thank Fr. Paul Attard OFM, for the good pastoral work as Port Chaplain.

After my appointment, I started immediately to work in this new (for me) Pastoral work. Fortunately for me after a few weeks I had to attend a seminar at Port de Bouc in Marseille where I met a number of Port Chaplains from various ports around Europe and started gaining a lot of experience. Coming in contact with these Port Chaplains and voluntary workers including my friend Deacon Rodriguez I started to see how they work in their country and learning from their vast experience.

Here I came to the conclusion that here in Malta you must have a professional way how to perform this mission. The first two things that came to mind were to build a monument dedicated to sea farers exactly at the entrance of the Grand Harbour in front of the church of Liesse. Secondly, a place near the same church to serve as a head quarters with all amenities were volunteer

liner “Admiral Nakhimov” sank in 7 minutes . 423 persons died and 65 had been missed in result of disaster. “Apostleship of the Sea” and “The Mission to Seafarers” together cares people which concern this tragedy. This year, as well as the last one, the memorial celebration begun with a requiem organized by “Apostleship of the Sea” and “The Mission to Seafarers” in Odessa port. The day after, 30 representatives of Ukraine with Fr.Olexander Smerechynskyy (“Stella Maris” chaplain) went to Novorossiysk (Russian Federation) to the place of the tragedy . A requiem has been served and flowers were thrown into the sea. Fr.Olexander Smerechynskyy had friendly meeting with Nikolay Motrenko (“Sailor Society” chaplain in Novorossiysk).

of the “Maritime Piracy: Humanitarian Response Program.”

In doing so ICMA has added its voice to the maritime community in vowing to stand by seafarers and their families when affected by piracy.

ICMA had long since resolved that it would support efforts to help seafarers affected by piracy. At the time ICMA called upon the industry to join its members in giving priority to the harm done to human lives when pirates strike. We are gratified that the industry has now come together as never before to battle the human tragedy of piracy. The program states:

An industry wide alliance of ship owners, unions, managers, manning agents, insurers and welfare associations (maritime, labour, faith or secular) has come together to establish the “Maritime Piracy: a Humanitarian Response Program” (MPHRP). The objectives of this program is to address the three phases of “pre-, during and post incident” of humanitarian response, with the aim of implementing a model of assisting seafarers and their families with the humanitarian aspects of a traumatic incident caused by a piracy attack, armed robbery or being taken hostage.

The Program intends to bring together ICMA’s projects and the other known initiatives to address the humanitarian fallout of piracy, to enable coordination and collaboration.

Most importantly, the Program will enhance the role of ICMA members’ chaplains and centre staff as first responders: it is we who meet first and face to face the seafarers and families who need help after piracy. The program was launched officially on World Maritime Day, 29th September 2011, in the Docklands of London.

## ICMA addresses piracy care at the 11th International Symposium on Maritime Health

The Rev. David M. Rider, President & Executive Director of ICMA member the Seamen’s Church Institute of New York and New Jersey, and Douglas B. Stevenson, ICMA’s Chairman, jointly represented ICMA at the 11th International Symposium on Maritime Health, held in Odessa, Ukraine.

Organised by the International Maritime Health Association, IMHA, the 4-day meeting brought together some 200 maritime health professionals from 42 countries to discuss the unique challenges of seafarer medical care while at sea and visiting ports around the world.

A special session addressed the unique medical and mental health challenges of seafarers affected by piracy. With hostage situations lasting an average of six months and, in an extreme case, 16 months, seafarers run out of prescription medications, endure poor nutrition and sanitation, and, of course, cope with extreme stress like mock executions and isolation from other crew.

Rider introduced SCI’s revised Post-Piracy Care for Seafarers Guidelines (version 3.0), addressing the medical and mental health support of seafarers and their families before, during and after hijacking episodes.

## 10<sup>th</sup> ICMA World Conference Hamburg 2011

208 chaplains, welfare workers and representatives of the maritime world from 41 different countries around the world gathered 19 to August 23, 2011 in Hamburg to celebrate the 10th World Conference of ICMA (International Christian Maritime Association).

Topics addressed during the conference:

- **ILO Convention 2006:** This agreement, of transcendent importance to the future of the sailors was presented by Dr. Cleopatra Doumbia-Henry Director of the International Labour Standards Department of the ILO, together with Doug Stevenson chairman of ICMA, Brian Orrel from the International Transport Workers Federation and Dierk Lindemann from the shipping fraternity. It was underlined the ICMA’s role in the convention’s development.

### **The Maritime Industry: Economic Situation**

Prof H Gerstenberger, Wolfgang Hurtienne, Hamburg Port Authority and Prof Christoph Wand analyzed the evolution of the maritime sector in the last 40 years and its future prospects.

### **Wellbeing of Seafarers - A Holistic Approach,**

presented by Dr Clara Schlaich & Jan Oltmanns

It addressed the needs of seafarers and pastoral work in terms of the brevity of scales, the growth of the ports, the proliferation of flags of convenience and the plurality of the crews.

### **Labour for Leisure - Serving Seafarers on Cruise Ships**

presented by Andrea Pesce, Markus Wichman and Giacomo Martino. It was analyzed the needs of the crews on board cruise ships and the welfare services for them in port.

- b) health of seafarers
- c) sailing chaplains
- d) welfare committees
- e) marine sports activities
- f) ISAN (International Service for seafarers)
- g) Assistance to cruise ship crews in port
